*note1: The shelf life of Super-Check / Super-Glo / Eco-Glo (water based type) is two years after manufacture.

D-LW•K, D-LW•N, D-LW•S is two years after manufacture.

*note2: The shelf life of Super-Magna conditioner (water based type) and Eco-magna conditioner EC-4, Antifoaming Agent 71A and Super-keep antirust AR-100K, AR-200K are one year after manufacture. Super Magna Fluorescent Magnetic Particle LY-10 SOL (water based type) and Super Magna Fluorescent Magnetic Particle LY-20 SOL (water based type) are two years after manufacture. Super Magna White Magnetic Particle WD-55 and Super Magna Red Magnetic Particle RD-203 are five years after manufacture.

*note3: Eco Color Remover PMW, Eco Color Remover PSW is two years after manufacture.

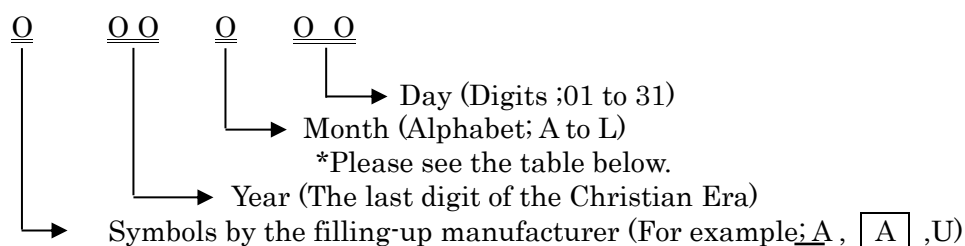
Eco Color Paint HT-1000 is one year after manufacture.

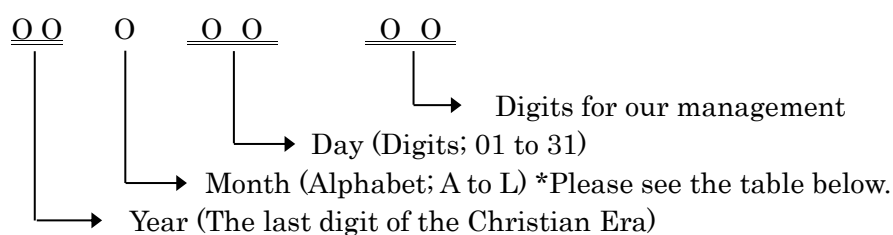
